

#### Why Group e-news is sent to groups

Groups have requested current information from the WSO.

Before Group e-news, correspondence sent by postal mailings was the only mode for the WSO to directly Communicate with groups. Mailing letters to all groups takes a few weeks and is costly. Electronic communication with groups allows the WSO to share information to groups that they would not ordinarily receive due to the publication process or postal mailing costs.

Since its inception, groups have been notified through Group e-news of opportunities to participate in time-sensitive projects such as surveys, podcasts, and outreach projects. Deadline reminders for Al-Anon Faces Alcoholism orders and updates about Al-Anon International Conventions are among the time-sensitive information groups received.

#### Sharing Group e-news and now In the Loop with your group members.

Groups determine through their group conscience process how information in Group e-news is shared with members of the group. Each group has the autonomy to decide how to share the information. Groups have notified the WSO of the following ways:

The CMA reads the newsletter and prepares a report.

The CMA prints out the newsletter, brings it to the group, and gives a report.

The newsletter is passed around the meeting.

The newsletter is posted on a group bulletin board or clipboard.

The group asks the CMA or another trusted servant to make a copy of the newsletter for each member.

The newsletter is forwarded to group members who have provided an e-mail address for that purpose.

#### **Service Aids Recovery**

For many years, I resisted the idea of doing service beyond the group level. I was afraid it would be too much—too much time, too much work. But after many years in the program, I knew my recovery needed a boost.

Service Aids Recovery sums up my experience, so far, Service work for me is putting Step Twelve into practice; it centers me in the spiritual practice of gratitude. When I stretch myself by doing service, I don't have as much time to wallow in negative attitudes of resentment or self-pity.

Recently, I was out of town for three weeks. It wasn't possible to find meetings where I was, or to do my usual Al-Anon service work (although, I did stay in touch with sponsees by phone and text.) During this time, there was a death in the family and I traveled to the Midwest for a big holiday meal, a wedding, and a funeral.

When I returned to New York, I needed to quickly pick up several service commitments, which included co-leading a Spiritual Stroll at our District 33 workshop, introducing the main Al-Anon speaker, and traveling to Long Island to facilitate a group inventory for forty group members the following day. After everything I'd just been through, I woke up on Sunday feeling some of my old negative attitudes. Why couldn't I just have one day for ME? But after reaching out to program friends, HP gave me the energy and the willingness to show up for my commitment.

That night, I had a wonderful experience at the Simple Sunday group inventory in Garden City. On Monday, I woke up feeling happier and more serene than I had in weeks.

I'm so grateful for service. It's exactly what I need to be the person I feel good about being.

At the last Area Assembly there was an interesting discussion about the advisability of such frequent visits, with the attendant budget expense. As I commented in my written report for that meeting, the Treasurer and I have agreed that this is an appropriate interval to avoid the pileup of mail, particularly donations, which become a logistical and administrative burden if allowed to accumulate to excess.

### Alateen Coordinator / Gerry L.:

Alateen is 61 years old this year. When the fellowship began with a California teen who wanted a program that was geared to kids his age, there were no personal computers let alone smart phones. Kids connected on the telephone...and, ready for it? Actually, they had to call back when they got busy signals. Yup. No call waiting. No voice mail. There weren't even any answering machines. They read books, sent snail mail, went to the rooms. Real rooms, inside real buildings. Church basements most likely. Just like today. But, today, recovery for teens is available via a variety of means. We cannot be too attached to what recovery for today's kids looks like.

The WSO now has a Teen Section on its website, complete with an Alateen Chat Room. While that may seem scary at first to old-timers, fear not, every chat session must be moderated by two certified AMIAS (Al-Anon Member Involved in Alateen Service), Alateen Sponsors, How that works in a nutshell is; each session is overseen by the WSO, must have two adults in the "room". Before a teen's comment is posted, it is reviewed by the AMIAS sponsors who can decide to upload it or not. A great way for kids to remain connected to recovery and share with one another.

The WSO is not being left in the 1957 dust when it comes to social media either. There are Instagram (Alateen WSO) and Twitter (Alateen WSO) pages along with a Facebook page to follow. All three are loaded with content: slogans, hashtags (those funny # signs that take you to somewhere related online,) and hot links to the WSO website, email and telephone number.

All-in-all, it's a great way for today's teens to find and stay connected and begin their road to recovery. So, can't get your teen to a traditional meeting? Try connecting them to these methods. It can make all the difference in the world.

A couple of quick notes on the training front: there were trainings on Long Island in September (Suffolk,) and November (Nassau,) and there will be an NYC training on January 6, 2018, as well as one in March in Westchester/Rockland. Check back on the Intergroup and Area websites for details.

# The Steps, Traditions, and Concepts

January [1] / February [2] / March [3]

### **Steps:**

- 1. We admitted we were powerless over alcohol That our lives had become unmanageable.
- 2. Came to believe that a Power greater than ourselves could restore us to sanity.
- 3. Made a decision to turn our will and our lives over to the care of God as we understood Him.

### **Traditions:**

- 1. Our common welfare should come first, personal progress for the greatest number depends upon unity.
- 2. For our group purpose there is but one authority a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants - they do not govern.
- 3. The relatives of alcoholics, when gathered together for mutual aid, may call themselves an Al-Anon Family Group, provided that, as a group, they have no other affiliation. The only requirement for membership is that there be a problem of alcoholism in a relative or friend.

## **Concepts:**

- 1. The ultimate responsibility and authority for Al-Anon world services belongs to the Al-Anon groups.
- 2. The Al-Anon Family Groups have delegated complete administrative and operational authority to their conference and its service arms.
- 3. The right of decision makes effective leadership possible.
